Budget – A motion was moved and 2nd to accept 2024 Proposed Budget as prepared with the adjusted amount of expenses at \$259,476.00 and income of \$180,200.00. Motion carried.

All committee reports were approved on a motion and 2nd. Motion carried.

A motion was made and 2nd to accept Pastor Mike Allwein to be our part-time interim pastor under the contract presented starting November 5. An amendment will be figured for the months of November & December 2023. Motion carried
